- (1) The financial bidding will be online through E-bidding system. Tender form can be filled online and downloaded from the official website of ML&C Deptt i.e. www.etender.mlc.gov.pk
- (2) The tender shall be cast electronically on or before 29.01.2024 upto 1100 hours and shall be opened on the same day at 1130 hours in the presence of tenderers or their authorized representatives, who may likely to be present.
- (3) All bidders are required to have valid NTN / STRN.
- (4) The bidder shall submit detailed quotation through Courier/Contractor Representative. **2.00% bid** security sealed in envelop of the estimated cost in shape of call deposit (Original) from scheduled bank before closing date and time.
- (5) Conditional and incomplete tenders wherein necessary details/CDR are missing will not be accepted.
- (6) Rate should be quoted on the basis on MIES schedule 2021 (amended up to date) for schedule items and market rate for non-schedule items.
- (7) Any bids received contravention of the relevant PPRA Rules, 2004 (amended up to date) will be declared non responsive by the Board being the procuring agency.
- (8) In case if the lowest bid is less than reasonable rates, the lowest bidder shall have to deposit standing security (refundable after success completion of the work) reasonable amount

decided by the undersigned in the shape of Call Deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and bid will be cancelled.

- (9) The quoted rates shall be valid till the completion of work and in any case no escalation shall admissible on any pretext.
- (10) All Govt. taxes shall be deducted from the bill as per rules.
- (11) Cantonment Board Mardan shall not supply any kind of material and machinery to the contractors.
- (12) The approved bidder shall furnish an agreement on non-judicial stamp paper.
- (13) Cantonment Executive Officer/Cantonment Board reserved the right to accept or reject all tenders (prior to approval) as per rule 33 (1) of PPRA Rules 2004.
